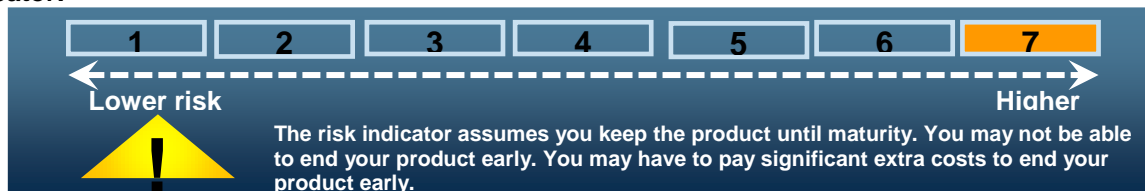
You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type:	An Over the Counter Derivative (OTC) contract – Deliverable Foreign Exchange Swap Instrument																		
Objective:	<p>The product achieves its objective by RBS International agreeing the terms of an OTC contract with you which is a package of two foreign exchange transactions. Under the first transaction you agree to exchange an agreed amount of currency 1 for currency 2 (together, the currency pair) with RBS International at a pre-agreed exchange rate, called the forward rate on a pre-agreed date (known as a settlement date). Under the second transaction, you agree to exchange the agreed amount of currency 2 for currency 1 with RBS International at a pre-agreed exchange rate on a later settlement date. The return on this product to the investor is dependent on the level of the pre-agreed exchange rate at which the currency pair is actually exchanged relative to the prevailing rate of exchange of the currency pair in the underlying spot market.</p> <p>You will be obliged to exchange the agreed amount of currency 1 for currency 2 to RBS International at each forward rate on the respective settlement date of each transaction. The amount of currency 2 purchased or sold may be greater or less than could be achieved at the prevailing rate of exchange of the currency pair in the underlying spot market on the respective settlement date and hence may result in a gain or loss to the investor.</p> <p>The illustrative terms of the product are set out below. Term:	<p>3 months. The exact duration of the product will be agreed at execution and will be set out with the other product terms in the confirmation of the transaction. It is a product which is entered into for its term. The product terms provide that if certain exceptional events occur, RBS International may terminate the product early. These events principally relate to your financial condition.</p>																		

What are the risks and what could I get in return?

Risk indicator:



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential loss from future performance at a very high level.

Be aware of currency risk. You will receive payment in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

This product does not include any protection from future market performance so you could incur significant losses. If RBS International is not able to pay you what is owed, you could incur significant losses.
